

**Dream Destination Giveaway #1
Official Rules**

NO PURCHASE, MEMBERSHIP OR PAYMENT NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. PARTICIPATION CONSTITUTES PARTICIPANT'S FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE "OFFICIAL RULES". VOID WHERE PROHIBITED.

I. SWEEPSTAKES PERIOD: The *Dream Destination Giveaway #1* (herein referred to as the "Sweepstakes" or "Promotion") begins on or about 12:00:01 a.m. Eastern Time ("ET") on November 29, 2024 ("Start Date") and ends at 11:59:59 p.m. ET on March 3, 2025 (the "Promotion Period"). The Sweepstakes is sponsored by Myl High Club LLC, 30 N Gould Street Ste R, Sheridan, WY 82801 (the "Sponsor"). The official clock for purposes of the Sweepstakes is the computer of the Sponsor.

II. ELIGIBILITY: The Sweepstakes is open to legal residents of forty-eight (48) United States (this excludes NY and FL) and the District of Columbia (D.C.), as well as residents of Canada, who are sixteen (16) years of age or older (exceptions - must be 19 years of age or older for those that reside in provinces of British Columbia, New Brunswick, Newfoundland, and Nova Scotia, and Northwest Territories, Nunavut and Yukon, and states of Alabama and Nebraska) and possess a valid driver license as of the date of entry. Parents or legal guardians of a Winner under the age of majority in their state of residence may be required to also sign the Prize Acceptance Release in order for the Grand Prize Winner to be qualified to receive their Prize. The Prize Acceptance Release is subject to verification by Sponsor.

Officers, members, directors, representatives and employees of the Sponsor and any of their respective parent companies, affiliated companies, subsidiaries, dealers, franchisees, licensees, distributors, suppliers, subsidiaries, participating retailers, advertising / promotion/judging agencies, persons engaged in the development, production or distribution of materials for this Sweepstakes, Compliance Sweepstakes Services, LLC (collectively, the "Released Parties") and the immediate family members (defined as spouse, parents, grandparents, children, grandchildren, siblings, - whether biological, adopted, step or in-law) of such individuals, or persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Participation constitutes Participant's full and unconditional agreement to these Official Rules and Sponsor decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. **Void in New York, Florida, Puerto Rico, the U.S. Virgin Islands, Guam, U.S. Military installations in foreign countries, and where prohibited, taxed, or restricted by law, regulation, or ordinance.**

III. HOW TO ENTER THE SWEEPSTAKES: An individual will be deemed a participant ("Participant" "Member" "MHC Ambassador" or "you") in the Sweepstakes if eligible and enters the Sweepstakes via any of the following three (3) entry methods:

1) Merchandise Purchase Entry Method: Visit <https://MylHighClub.com> (the "Website" and "Member Log in Portal") and complete a purchase of apparel and/or promotional merchandise featured on the Website during the Promotion Period. For each One Dollar (\$1.00) spent via approved credit card transaction (excluding sales tax, shipping charges and any discounts), the Participant receives one (1) Entry into the Sweepstakes drawing. Participants are required to provide: first and last name, home address, telephone number (for winner contact only), e-mail address and the name and email of their travel guest. Dollars are rounded to the next highest amount to determine the number of entries for an order.

Multiple Bonus Shopping Periods ("Multiple Bonus Period(s)"): Throughout the Promotion Period, the Sponsor will announce opportunities on the Website or via an e-mail outreach, for Participants to earn MULTIPLES of Two Times (2X), Three Times (3X) or Five Times (5X) Entries, based on the total purchase (excluding sales tax, s&h charges and any discounts). For every \$1.00 spent during the specified Multiple Bonus Periods, a Participant receives the advertised Bonus Entries into the Sweepstakes drawing. LIMITS: There is a limit of five thousand (5,000) Merchandise Purchase Entries and three thousand (3,000) Multiple Bonus Entries ("Bonus Entries") per Participant.

2) Membership Enrollment Method of Entry: To receive one hundred (100) Entries ("Entry(ies)") go to <https://mylhighclub.com/> (the "Website" and "Member Log in Portal"), click on "Get Bonus Entries" to learn about the Myl High Club ("MHC") and membership program. Enroll in one of the three (3) club membership programs: the *Free Basic Member* program; or the *First Class* membership program (\$14.99 monthly fee) to receive Five Times (5X) Entries on all purchased merchandise; or, the *Captains Member* program (\$24.99 monthly fee) to receive Ten Times (10X) Entries on all purchased merchandise. In

addition, *First Class* Members receive 250 Entries each month their membership is current, and *Captains* Members receive 500 Entries each month their membership is current. A 3-month minimum membership commitment is required. If a membership is canceled prior to the 3-month expiration date the *First Class* Member receives only 150 Entries and the *Captains* Members receive only 250 Entries. Each of the aforementioned memberships offer various discounts, unique destination deals and experiences, Sweepstakes entry opportunities and more. Enrollment requires: first and last name, home address, telephone number (for winner contact only), e-mail address and the name and e-mail of the travel guest. Before a registered Member adds any person's name and e-mail to their registration form, the potential travel guest's permission is required.

Note: Travel Guest Terms and Conditions: In the Membership Enrollment Method of Entry, a Member's friend or family travel guest will be emailed a free Myl High Club newsletter. The Grand Prize Winner's guest is required to become a registered MHC Member to qualify as a travel guest. Membership is free.

3) MHC Ambassador and Ambassador's Program: All Participants who have purchased merchandise or became a Myl High Club Member are to go to the MHC Member Log-in to receive or to access their unique MHC Ambassador Code ("Code"). Participants who are now identified as a MHC Ambassador ("MHC Ambassador") are to go to <https://mylhighclub.com/> and follow the prompts to invite friends or family to participate in the Promotion. One Hundred (100) Affiliate Entries is awarded to a registered MHC Ambassador for each qualified friend and family member who registers to enter the Sweepstakes using your Code. The friend or family member in turn is issued a unique MHC Ambassador Code. You may only refer persons with whom you have an existing personal relationship and who would not consider an e-mail from you to be spam. Additionally, in order for you to be credited with the 100 Affiliate Entries, the friend or family member you invite must meet the eligibility requirements outlined in Rule #II. You may invite a maximum of fifty (50) friends or family members and may not invite the same person more than once. If your friend or family member does not want his/her e-mail address used for future marketing purposes, he/she must check the appropriate box on their entry form. If the friend or family member chooses not to be added to the Sponsor's mailing list, they will not receive any further correspondence from Sponsor unless they are selected as a prize winner.

4.) Mail-In Method of Entry: Participants may enter without the purchase or membership obligation by legibly hand printing on a 4" x 6" postcard or paper, in black or blue ink, your first name, last name, mailing address, city, state/province, zip/postal code, day and evening phone numbers (to be used for winner contact only), e-mail address (if available) date of birth and your travel guest's name and email if you should be selected as the Grand Prize Winner. The potential guest must give the entering Participant permission to include their information on the entry form. Mail each postcard separately in a **hand printed first class stamped #10 business size envelope** to: Compliance / Myl High Club Giveaway #1, P.O. Box 468, Stonington, CT 06378. **The return address on the envelope must also be hand-printed with the sender's full name and address.** Rubber stamped or commercial printed return address labels will void the entry. Each correctly submitted envelope receives three hundred (300) entries, with a limit of Five Thousand (5000) entries into the Sweepstakes drawing. Postcards mailed without being inserted into a business size envelope are voided. All final mail-in entries must be postmarked by March 3, 2025 and received by March 7, 2025.

Multiple Bonus Mail-In Periods: During each specified Multiple Bonus Period, mail-in entries must follow the aforementioned mail-in entry submission procedure: (i) handwrite the words MULTIPLE 2X, MULTIPLE 3X, MULTIPLE 5X that corresponds to the Sponsor's announced merchandise multiplier opportunity; (ii) the Bonus Shopping date ("Bonus Date") for each specific merchandise multiplier offer; (iii) the product name of the merchandise item or merchandise product ID number; (iv) the cost stated on the promoted multiplier merchandise item. **This information must appear in the lower left envelope corner or on the back of the envelope if space is required,** which will be relied upon to qualify a Participant's Bonus Multiplier Entries. The postmark date must correspond to the announced entry Multiple Bonus Date, or the mail-in entry only receives three hundred (300) Entries. There is a limit of three thousand (3,000) Multiple Bonus Entries per Participant. All mail-in Entries must include all requested information and format (as stated above) to be considered a valid entry. Bulk shipments (multiple entries in one shipping package) will not be accepted and will be destroyed. Limit one (1) mail-in entry per envelope. Requests for confirmation of receipt of mail-in entries will not be acknowledged. Mail-in entries must be original; no photocopies, facsimiles or reproductions of a mail-in entry will be accepted.

Entry Limits: Five Thousand (5,000) Entries per person regardless of method of entry. However, a limit of Three Thousand (3,000) Multiple Bonus Entries are allowed per Participant.

All required information must be completed to enter and to be eligible to win. Incomplete Entries will be disqualified. Internet Entries must be made by the Participant only at the aforementioned Website(s) and application URL addresses. Entries made by any other individual or any entity, and/or originating at any

other website or e-mail address, including, but not limited to, commercial Sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. Sponsor reserves the right, in its sole discretion, to void any and all Entries the Sponsor believes has attempted to tamper with, influence or impair the administration, security, fairness, or proper play of this Sweepstakes. Proof of entering information is not considered proof of delivery to or receipt by Sponsor of an entry. The use of automated entry devices is prohibited, and no mechanically reproduced entries are allowed; all such Entries are void. Released Parties are not responsible for: lost, late, incomplete, illegible, incorrect, damaged, delayed, garbled, undelivered, misdirected, or postage-due registrations Entries or mail, will be disqualified. All Entries become the exclusive property of Sponsor and will not be acknowledged or returned. In the event of a dispute about Entries submitted by multiple individuals using the same e-mail account, Entry will be deemed to have been submitted by the authorized subscriber of the e-mail account used to enter this Sweepstakes at the actual time of entry. The authorized e-mail-account subscriber is deemed to be the natural person who is assigned an e-mail address by an Internet-access provider, online-service provider, or other organization that is responsible for assigning e-mail addresses or the domain associated with the submitted e-mail address.

WINNER SELECTION: The potential Grand Prize winner will be selected from among all eligible Entries received, in an automated random drawing process, on or about March 14, 2025, by a third-party administrator ("the Administrator"), an independent judging organization, whose decisions are final in all matters relating to this Sweepstakes. Potential Winner will be notified by phone and/or e-mail. If the potential Winner cannot be contacted or does not respond within two (2) calendar days of the initial notification, or does not respond with complete contact information as requested by voice message, or whose phone provider indicates that the phone number is invalid or unable to receive the communication (even if ultimately delivered thereafter), or found to be ineligible, cannot or does not comply with these Official Rules, or if his/her prize or prize notification is returned as undeliverable, such potential Winner will be disqualified and an alternate potential Winner may be selected at Sponsor's sole discretion. All methods of entry have an equal chance of winning. Odds of winning in this drawing depend upon the number of entries received by the time of the drawing.

V. PRIZE ("Prize"): There will be one (1) Grand Prize awarded at the conclusion of the Promotion Period. The Grand Prize Winner ("Winner"), upon confirmation of eligibility, will receive up to an 8-day/7-night special vacation experience for two (2) adults at one of the locations featured at <https://MylHighClub.com>. The Prize includes one room (double occupancy), three (3) paid activities/excursions, two (2) first class tickets and local airport transfers. The Approximate Retail Value ("ARV") of the Prize is \$10,000. In addition, winner receives \$5,000 for other incidentals. Total Grand Prize ARV is \$15,000. (USD) Grand Prize winner must submit to Sponsor their selected destination no less than 30-days prior to requested departure date, and travel must be redeemed within the year of the printed prize certificate date. The Winner and travel companion are solely responsible for obtaining documents necessary for their respective international travel (i.e., passport and visa if applicable).

VI. GRAND PRIZE PACKAGE CONDITIONS: Prize suppliers will make every effort to confirm accommodations and airfare reservations for the *Dream Destination Giveaway #1* Prize Package (“Prize Package”) as requested, however, operational and/or market conditions may prevent them from doing so on the specified dates. Travel restrictions, conditions and limitations may apply, all of which are subject to change at Sponsor’s sole discretion. Travel is subject to the terms and conditions set forth in this Sweepstakes, and those set forth by Sponsor’s Prize Package contract. Once travel commences, no stopovers are permitted; if stopover occurs, full fare will be charged from stopover point for the remaining segments, including return, of the trip. Trip may not be combined with any other offer and travel may not qualify for frequent flyer miles. All expenses not specifically mentioned in Section V or in the Sponsor’s Prize Package contract, are not included as part of the Prize, and are solely the Grand Prize Winner’s responsibility, including, but not limited to: hotel taxes, additional ground transportation not specified, travel insurance, room service, bag check fees, parking fees, laundry service, food, alcoholic beverages, merchandise, souvenirs, telephone calls, tips, gratuities and service charges, site-seeing excursions and any other incidental costs or expenses not identified in the Prize Package contract. Additional Prize award details and travel information to be provided to the Winner at the time of scheduling.
